COUNCIL PROCEDURE AMENDMENT BYLAW NO. 3431, 2018

BEING A BYLAW TO AMEND THE CITY OF PRINCE RUPERT
COUNCIL PROCEDURE BYLAW NO. 3092, 2000

The Council of the City of Prince Rupert, in an open meeting assembled, enacts as follows:

That the Council Procedure Bylaw No. 3092, 2000 be amended as follows:

1. By amending Part 2 – INAUGURAL MEETING, Section 5 – Inaugural Meeting, subsection (1) to read as follows:

The first regular Council meeting following a general local election must be held on the first Monday in the month following the general local election.

2. This Bylaw may be cited as **“Council Procedure Amendment Bylaw No. 3434, 2018”**.

Read a Second time this 22nd day of October, 2018.

Read a Third time this 22nd day of October, 2018.
