

CITY OF PRINCE RUPERT
REVISION BYLAW NO. 3444, 2019

BEING A BYLAW TO AUTHORIZE THE REVISION OF A BYLAW

WHEREAS section 140 of the *Community Charter* permits a Council, by bylaw, to authorize the revision of all or any of the bylaws of the municipality in accordance with the *Bylaw Revision Regulation* (B.C. Reg. 367/2003);

AND WHEREAS the City has identified a clerical error in City of Prince Rupert Bylaw No. 3438, 2019 and Prince Rupert Bylaw No. 3439, 2019 that requires a revision to improve the expression of the law without changing its substance.

NOW THEREFORE the Council of the City of Prince Rupert, in open meeting assembled enacts as follows:

TITLE

1. This bylaw may be cited for all purposes as “**City of Prince Rupert Revision Bylaw No. 3444, 2019**”.

BYLAW REVISION

2. The City of Prince Rupert Bylaw No. 3438, 2019 is hereby revised by attaching the Schedule “A” attached hereto.
3. The City of Prince Rupert Bylaw No. 3439, 2019 is hereby revised by attaching the Schedule “A” attached hereto.

ADOPTION OF THE REVISED BYLAW

4. The revised City of Prince Rupert Bylaw No. 3438, 2019 shall take effect:
 - a) following the certification of the Corporate Administrator prior to the third reading that it has been revised in accordance with this bylaw, and
 - b) upon its subsequent adoption by the Counciland pursuant to the *Community Charter* the revised City of Prince Rupert Bylaw No. 3438, 2019 shall be deemed to have been adopted as if all statutory requirements respecting the approval and adoption of the City of Prince Rupert Bylaw No. 3438, 2019, including consultation, notification, and a public hearing, had been met.
5. The revised City of Prince Rupert Bylaw No. 3439, 2019 shall take effect:
 - a) following the certification of the Corporate Administrator prior to the third reading that it has been revised in accordance with this bylaw, and
 - b) upon its subsequent adoption by the Counciland pursuant to the *Community Charter* the revised City of Prince Rupert Bylaw No. 3439, 2019 shall be deemed to have been adopted as if all statutory requirements

respecting the approval and adoption of the City of Prince Rupert Bylaw No. 3439, 2019, including consultation, notification, and a public hearing, had been met.

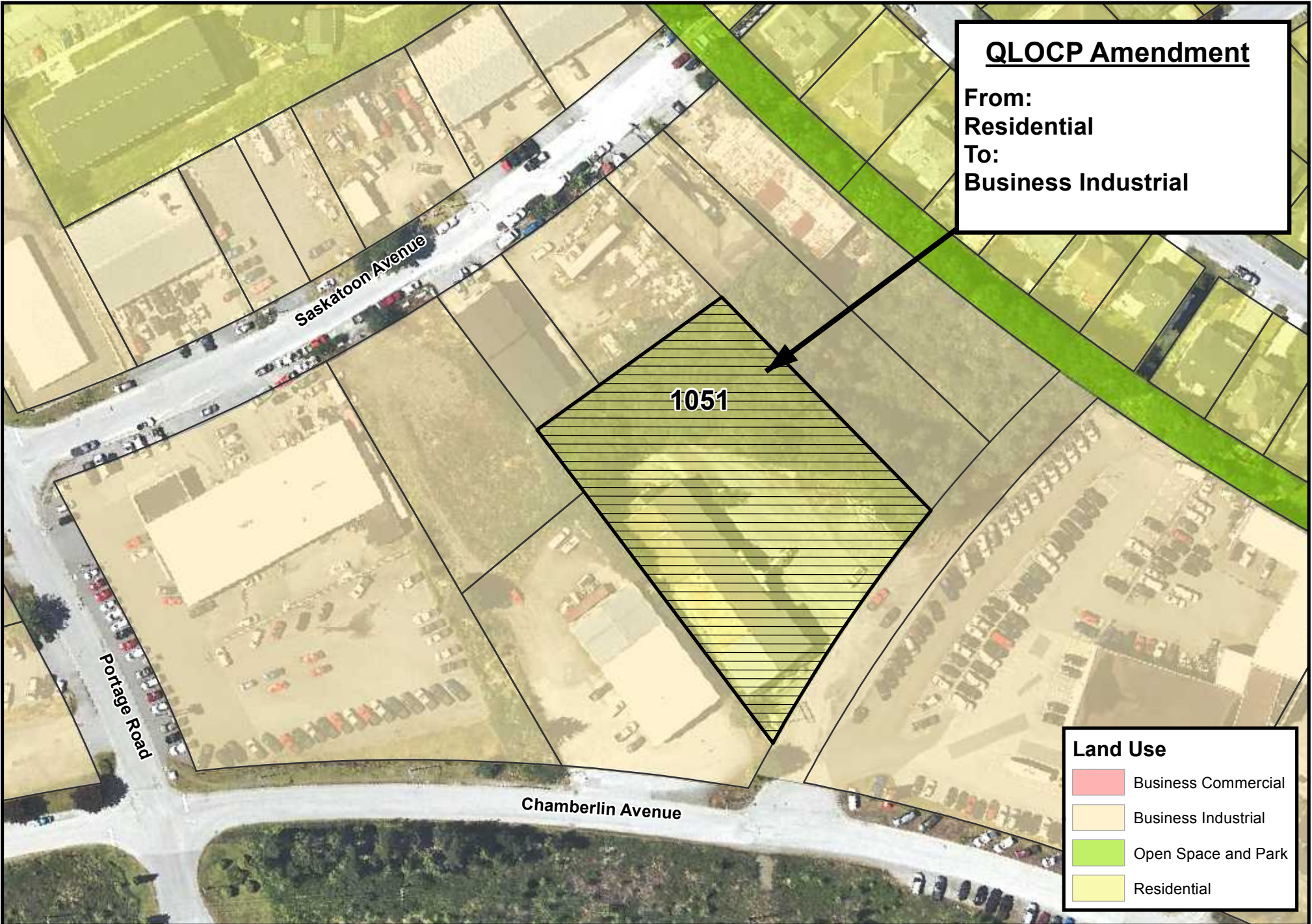

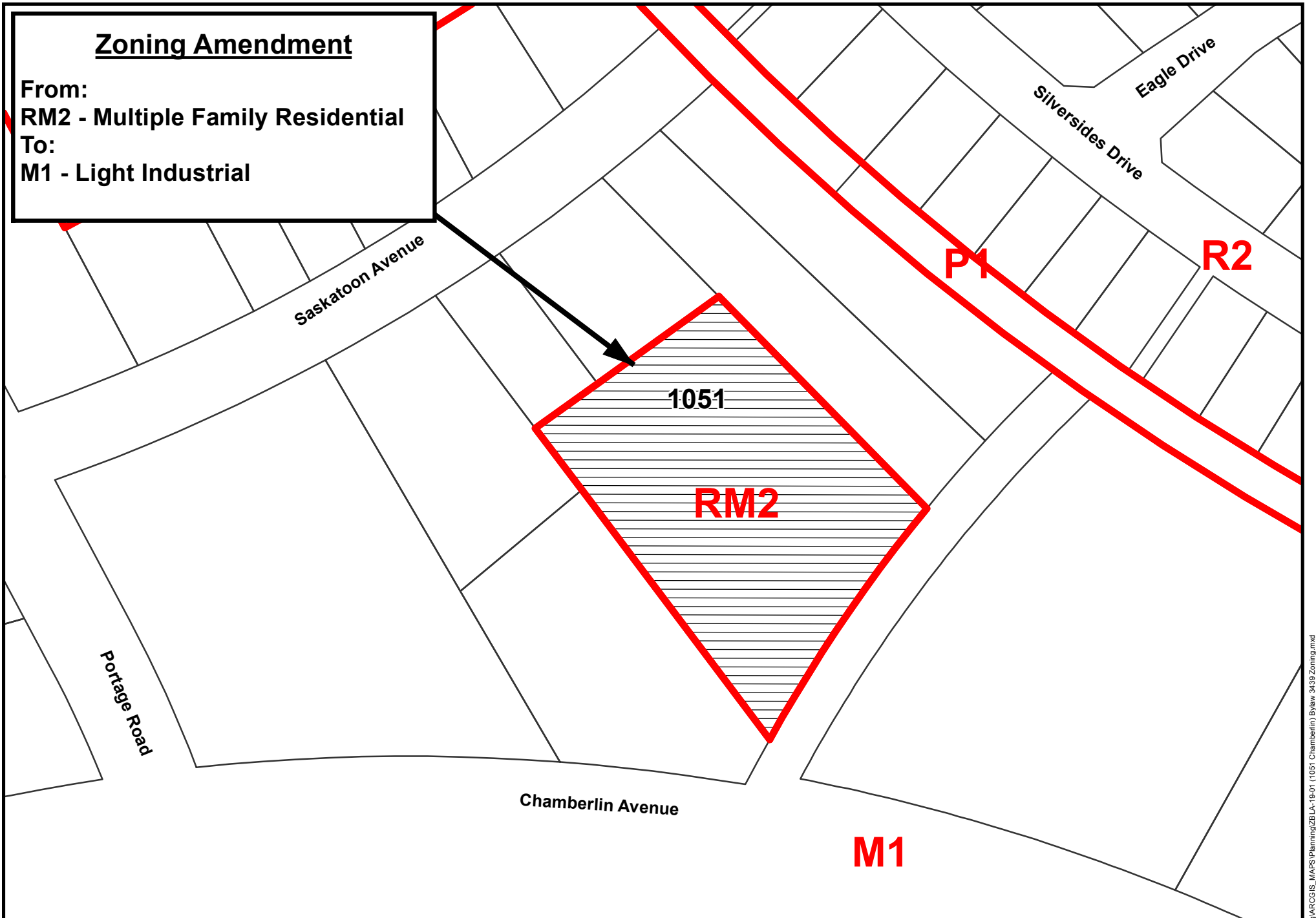
