## QUALITY OF LIFE OFFICIAL COMMUNITY PLAN AMENDMENT BYLAW NO. BYLAW 3445, 2019

BEING A BYLAW TO AMEND THE CITY OF PRINCE RUPERT QUALITY OF LIFE  
OFFICIAL COMMUNITY PLAN BYLAW NO. 3236, 2007

The Council of the City of Prince Rupert in an open meeting assembled, enacts as follows:

That the City of Prince Rupert Quality of Life Official Community Plan of Bylaw No. 3236, 2007 be amended as follows:

1. That consolidated lots 45 to 53 included in REFERENCE PLAN OF LOTS 32 TO 35, PARCEL A AND LOTS 39 TO 53, BLOCK 29, SECTION 1, PLAN 923 AND CLOSED ROAD SHOWN ON PLAN EPP51593, ALL IN DISTRICT LOT 1992, RANGE 5 COAST DISTRICT, shall be amended as follows:  
  
From: Residential  
To: Business Commercial
2. That the Long Range Land Use Plan Map 1 which forms a part of the Quality of Life Official Community Plan No. 3236, 2007, shall be amended according to Schedule "A", attached and forming part of the Bylaw No. 3445, 2019.
3. This Bylaw may be cited as **"Quality of Life Official Community Plan Amendment Bylaw No. 3445, 2019"**.

Read a First time this 10<sup>th</sup> day of June, 2019.

Read a Second time this 22<sup>nd</sup> day of July, 2019.

Public Hearing held on the 19<sup>th</sup> day of August, 2019.

Read a Third time this 19<sup>th</sup> day of August, 2019.

Final consideration and Adopted this 9<sup>th</sup> day of September, 2019.

This Bylaw was adopted by Council.
