#### RECOMMENDATION:

#### **REASON FOR REPORT:**

To provide an update to Council on the activities relating to Communications and Social Development occurring with the Administration Department in 2024.

#### **BACKGROUND:**

With the City's Administration Department, cross-Departmental support is provided for communications and engagement, and also administrative support and capacity for several social development related initiatives. In addition to specific projects and initiatives noted below, this function provides communications advice, guidance, and review to the senior management team as needed. Operational support is also provided for day-to-day communications activities occurring across departments such as Annual Report development, budget consultations, and other regular updating to the community. Finally, grant writing and review is also supplied on an as-needed basis for projects.

#### LINK TO STRATEGIC PLAN:

Several activities below are in direct support of Council's goals under the 2023-2026 Strategic Plan.

#### ANALYSIS:

This report highlights notable department activities in 2024, with information provided below.

#### **Support for Strategic Initiatives**

- Communications and grant writing support was provided as needed for Hydrogen development + Innovative Energy Hub to Economic Development, including promotion of the RFEI, press event coordination support, and promotional materials development;
- Developed Equity Lens Policy, adopted Q4 2024 and Report to Council Template updated to reflect policy guidance. Lunch and learn event provided to staff;
- Working to align local programming with Indigenous Engagement Requirements within the Emergency and Disaster Management Act (EDMA), as per Provincial Directive (Section 55 of EDMA). MOU signed to collaborate with Port Ed, Regional District, additional grant applied to generate local cultural safety training materials;
- Communications support for the BIG Project ongoing with project page, FAQs, releases and notices occurring in 2024 and continuing into 2025 and beyond;
- Secured funding to replace 3 bus shelters in priority locations to be installed in 2025;
- Provided grant writing support and initial coordination work for traffic calming initiative at CHSS intersection. Final scope of work increased due to area water break and was completed by Operations;

## **Community Engagement & Training:**

- Community engagement, development and adoption of an Accessibility Plan in coordination with the Regional District, Library and District of Port Edward;
- Indigenous Relations committee meetings ongoing. Matriarchs tea event hosted and funds awarded to Indigenous Education for mural project following call for projects;
- Grant writing to support cultural safety training for 50 staff in 2024 and with regional materials under development that can be rolled out in future to remaining and new staff;
- Support for local Situation Table through co-chairing weekly meetings with Victim Services to support continued success of the local program that provides support to those in the community who are at acutely elevated risk. Coordinated safety training for social service providers coordinated and completed Q3 2024

## **Support for Planning Activities:**

- Support for the Planning Department for regulatory updates required by the Province for small scale and multi-unit housing, our housing needs assessment, updates to our Official Community Plan, short term rental housing, and development approvals process review and grant support. Work to update our OCP and development approvals processes are continuing into 2025;
- Engagement support and review provided to the Complete Communities Plan and Climate Plan;
- Completed the Social Development Assessment in collaboration with the Planning Department, adopted in 2024;

#### **RECOMMENDATION:**

THAT Council consider this report in regards to Highway Road Closure Bylaws Nos. 3555 & 3556.

#### **REASON FOR REPORT:**

In 2024, Council approved the sale of land to School District 52 for the development of the new middle school. The undeveloped road right of ways indicated in these bylaws are proposed to be closed to be sold as part of that land transfer. The School District intends to consolidate the land into one parcel and allow the school to be built along 9<sup>th</sup> Avenue West.

#### **BACKGROUND:**

The road right of ways proposed for closure in this plan are currently undeveloped. One is a road right away that leads to the current SD52 property and does not provide access to any other properties. The school proposes to develop this as the primary access to the school. Closing this road will put primary maintenance of that driveway onto the school district, reflecting the current access which is on a parcel.

Bylaw No. 3356 proposes to close a section of undeveloped laneway behind lots fronting along 9<sup>th</sup> Avenue that are owned by the School District or are being sold to them. Maintenance and servicing agreements will ensure that any City infrastructure within this laneway is easily maintained and updated.

#### LINK TO STRATEGIC PLAN:

This action supports the strategic goals of providing good governance by working with other governments, residents, neighbouring communities to ensure collaboration and open government.

## HIGHWAY ROAD CLOSURE BYLAW NO. 3555, 2025

#### BEING A BYLAW TO CLOSE A PORTION OF HIGHWAY ALLOWANCE

Pursuant to Section 40 of the *Community Charter*, Prince Rupert City Council may, by bylaw, close a portion of a highway to traffic and remove the dedication of the highway, if prior to adopting the bylaw, Council publishes notices of its intention in a newspaper and provides an opportunity for persons who consider they are affected by the bylaw to make representations to Council;

The Council of the City of Prince Rupert deems that it is in the public interest to close to traffic, remove the dedication of highway comprising of approximately 278.361 sqm of dedicated Highway on Plan 923, which is shown outlined in bold black on the reference plans EPP142596 prepared by McElhanney, a reduced copy of which is attached hereto (the "Road Closure Plan");

The City intends to close that portion of highway to sell for consolidation with a neighbouring lot.

Notices of Council's intention to close that portion of highway to traffic, to remove its dedication as highway, and published in a newspaper and posted in the public notice posting place, and the Council has provided an opportunity for persons who consider they are affected by the closure and disposition to make representations to Council; and

The Council of the City of Prince Rupert does not consider that the closure of the Closed Road will affect the transmission or distribution facilities or works of utility operators;


The Council of the City of Prince Rupert, in an Open meeting assembled, enacts as follows:

- 1. Attached to this Bylaw as Schedule "A" and forming part of this Bylaw is a reduced copy of the explanatory plan of highway closure (the "Road Closure Plan").
- 2. The City hereby authorizes the closure to traffic and removal of highway dedication of the 278.361 sqm portion of highway which was dedicated as

- highway at the New Westminster Land Title Office by Plan 923, outlined in Bold on the Road Closure Plan (the "Closed Road").
- 3. On deposit of the Road Closure Plan and all other documentation for the closure of the road allowance in the New Westminster Land Title Office, the Closed Road is closed to public traffic, it shall cease to be public highway, and its dedication as a highway is cancelled.
- 4. The Mayor and Corporate Administrator are authorized to execute all deeds of land, plans and other documentation necessary to effect this road closure and disposition.
- 5. This Bylaw may be cited as <u>"HIGHWAY CLOSURE BYLAW NO. 3555, 2025"</u>

## HIGHWAY ROAD CLOSURE BYLAW NO. 3556, 2025

#### BEING A BYLAW TO CLOSE A PORTION OF HIGHWAY ALLOWANCE

Pursuant to Section 40 of the *Community Charter*, Prince Rupert City Council may, by bylaw, close a portion of a highway to traffic and remove the dedication of the highway, if prior to adopting the bylaw, Council publishes notices of its intention in a newspaper and provides an opportunity for persons who consider they are affected by the bylaw to make representations to Council;

The Council of the City of Prince Rupert deems that it is in the public interest to close to traffic, remove the dedication of highway comprising of approximately 434.625 sqm of dedicated Highway on Plan 923, which is shown outlined in bold black on the reference plans EPP142597 prepared by McElhanney, a reduced copy of which is attached hereto (the "Road Closure Plan");

The City intends to close that portion of highway to sell for consolidation with a neighbouring lot.

Notices of Council's intention to close that portion of highway to traffic, to remove its dedication as highway, and published in a newspaper and posted in the public notice posting place, and the Council has provided an opportunity for persons who consider they are affected by the closure and disposition to make representations to Council; and

The Council of the City of Prince Rupert does not consider that the closure of the Closed Road will affect the transmission or distribution facilities or works of utility operators;

The Council of the City of Prince Rupert, in an Open meeting assembled, enacts as follows:

- 1. Attached to this Bylaw as Schedule "A" and forming part of this Bylaw is a reduced copy of the explanatory plan of highway closure (the "Road Closure Plan").
- 2. The City hereby authorizes the closure to traffic and removal of highway dedication of the 434.625 sqm portion of highway which was dedicated as

- highway at the New Westminster Land Title Office by Plan 923, outlined in Bold on the Road Closure Plan (the "Closed Road").
- 3. On deposit of the Road Closure Plan and all other documentation for the closure of the road allowance in the New Westminster Land Title Office, the Closed Road is closed to public traffic, it shall cease to be public highway, and its dedication as a highway is cancelled.
- 4. The Mayor and Corporate Administrator are authorized to execute all deeds of land, plans and other documentation necessary to effect this road closure and disposition.
