### **RECOMMENDATION:**

That Council introduce and give First, Second and Third Readings to the Police Detachment Loan Authorization Bylaw No. 3484, 2022.

### REASON FOR REPORT

Under Community Charter 179 (1)(a) Council is authorized to incur a liability for a capital purpose. The City's current police detachment, which was constructed in 1978 and occupied by the Royal Canadian Mounted Police (RCMP) is no longer compliant for their needs and must be replaced as part of the City's obligation to provide adequate accommodation as is specified in the Municipal Police Unit Agreement April 1, 2012. This bylaw seeks to obtain financing necessary to construct a new police detachment on land the City purchased in 2020 for this express purpose.

### **ANALYSIS**

The new police detachment project will include engineering, design, construction, furnishing and commissioning. The project is expected to be complete and occupancy achieved in 2024. Recognizing the CleanBC objectives under the Roadmap to 2030, the City intends for this municipal building to be one of the first constructed with emphasis on the reduction of GHG emissions achievable within budget.

### **ESTIMATED COST:**

The cost of this project is estimated at \$25,000,000. Full project costs are to be funded through debt financing.

### FINANCING PROCESS:

Municipalities ordinarily finance large projects with loans from the Municipal Finance Authority. Provincial legislation and related regulations define the maximum amount a municipality may borrow; the maximum length of the loan (30 years); and, the process that must be followed to acquire a loan.

### Loan Capacity

Assuming the period of loan repayment is 30 years, the City has the borrowing capacity to borrow the amount required.

### Loan Period

The City anticipates borrowing for 30 years.

### Loan Process

The loan acquisition process requires that a Municipality must either put the question of obtaining the loan through a process called the *Alternative Approval Process* or alternatively put the question to *Referendum*. Before initiating either process of approval, the City must give three readings of the proposed Municipal Loan Authorization Bylaw and then submit the Bylaw to the provincial government for approval.

A brief summary of the two processes follows:

### Alternate Approval Process

This process requires the City to follow a public notification process advising the Community of the intent to borrow funds for the project. Voting members of the Community then have a period of time during which they can indicate that they do not approve borrowing money for the project. If ten percent (10%) of the eligible voting members indicate that they do not approve borrowing money, the question must then seek approval through a referendum process.

### Referendum

This process requires the Community to vote on the question of whether it approves the borrowing of funds for the project. A simple majority decides the question. Voting eligibility is the same for voting at a municipal election.

### FINANCING COSTS:

Should the electorate accept the undertaking of debt financing to construct the new police detachment, and Council adopts this Bylaw at a later date, the City will bring forth a Temporary Borrowing Bylaw with which funds will be drawn down on as needed to finance the construction of the detachment. Payments during this time will consist of interest only amounts. Once the project is complete, the final borrowing amount will be known and the City can trigger the long term debt by converting the Temporary Borrowing into debenture financing with the Municipal Financing Authority (MFA).

Table 1 shows the estimated annual cost of debenture financing should the entire \$25,000,000 loan be required. The interest rate of 2.35% is the current MFA estimated lending rate for 30 years.



The above table is an estimate given the interest rate may differ at the time the debenture debt is undertaken. The effects to the property tax rate for the repayment of this debt are estimated to be an increase of approximately 1% because the City reserved the majority of the annual repayment when new taxation was realized through the construction of industrial projects a couple of years ago. This action has reduced the taxation impact of loan repayments for this project to the overall tax base significantly. Should the full loan not be necessary, there may be no need for a tax increase with respect to this debt.

### TIMING OF LOAN AUTHORIZATION PROCESS:

The following diagram provides information as to the length of time necessary to obtain approval to obtain the municipalities authorization to borrow funds.



### LOAN AUTHORIZATION BYLAW:

A Loan Authorization Bylaw has been prepared (see *Attachment 1*) and sets the maximum amount that could be borrowed and spent pursuant to the Bylaw.

### **CONCLUSION:**

By introducing and giving Three Readings to the Bylaw, Council will initiate the loan authorization process.

## POLICE DETACHMNT LOAN AUTHORIZATION BYLAW NO. 3484, 2022

A BYLAW TO AUTHORIZE THE BORROWING OF FUNDS, FOR THE PURPOSE OF FUNDING THE POLICE DETACHMENT PROJECT

WHEREAS it is deemed desirable and expedient to construct a new police detachment in the municipality.

AND WHEREAS the estimated cost of the new police detachment including expenses incidental thereto is \$25,000,000 of which the sum of \$25,000,000 is the amount of debt intended to be borrowed by this bylaw;

NOW THEREFORE, the Council of the City of Prince Rupert in open meeting assembled, enacts as follows:

- 1. The Council is hereby empowered and authorized to undertake and carry out or cause to be carried out the construction of the new police detachment and to do all things necessary in connection therewith and without limiting the generality of the foregoing:
  - a) To borrow upon the credit of the Municipality a sum not exceeding twenty five million dollars (\$25,000,000).
  - b) To acquire all such real property, easements, rights-of-way, licenses, leases, rights or authorities as may be requisite or desirable for or in connection with the construction of the said police detachment project.
- 2. The maximum term for which debentures may be issued to secure the debt created by this bylaw is <u>thirty (30)</u> years.
- 3. This Bylaw may be cited as "Police Detachment Loan Authorization Bylaw No. 3484, 2022".

- 2. This Bylaw may be cited for all purposes as "City of Prince Rupert Zoning Amendment Bylaw No. 3479, 2021"
