A BYLAW TO AMEND FEES AND CHARGES AMENDMENT BYLAW NO. 3165, 2003.

WHEREAS Section 194 of the *Community Charter*, SBC 2003, Chapter 26, authorizes Council to, by bylaw, impose fees payable in respect of services of the City or the exercise of its authority to regulate, prohibit or impose requirements;

AND WHEREAS the *Community Charter*, SBC 2003, Chapter 26, authorizes Council to adopt and amend bylaws relating to the provision of services or the exercise of its authority to regulate, prohibit or impose requirements;

NOW THEREFORE the Council of City of Prince Rupert in open meeting assembled, enacts as follows:

Schedule A

Pursuant to Section 194 of the Community Charter, SBC 2003, Chapter 26, there is hereby levied a fee for police services provided as follows:

\$75.00 First Hour **Requests for Information**

\$10 for every additional 15 mins

Per carriers' invoice Registered Mail/Purolator

Fingerprinting \$30 per set plus \$25 Cheque or Money Order to Receiver General of Canada

Fingerprinting- Volunteers- Non Profit

Organizations No charge

Police Information/ VS Check-

Including all applicants who live inside or outside the Municipality that attend to the Prince Rupert Detachment

\$50.00 per application (If fingerprints are required, then \$25 Cheque or Money Order to Receiver General of Canada)

Police Information/ VS Check-No Charge (unless fingerprints are Including all applicants who live outside the required, then \$25 Cheque or Money Order to Receiver General of Municipality that attend the RCMP facilities

in their community Canada)

Police Information/ VS Check- Volunteers-

Non Profit Organizations No Charge

Chauffeur's Permit \$80.00 per application (If fingerprints

> are required, then \$25 Cheque or Money Order to Receiver General of Canada)

Mechanical Inspections Actual cost of inspection

DVD, CD, & Jump Drive \$20.00 each

Photocopying \$0.50 per page

Descriptions of the police services are more particularly described as:

*Requests for Information

Consent Orders

Removing non-conviction information from Criminal History

Written reports regarding property crimes and motor vehicle accidents; copies of witness statements; photocopying.

MV6020's ICBC – including measurements, field diagrams, photographs

MV6020 & Worksheet - Motor vehicle accident reports whereby RCMP may/may not be required to attend. Completed forms require opinion of RCMP.

Fingerprint Set

Fingerprints required for employment, criminal record checks, and private investigator's license.

<u>Fingerprint Set - Volunteers - Non-Profit Organizations</u>

Bona fide registered non-profit organizations where no remuneration is received. Letter on organization's letterhead and registration number must validate the application.

Police Information/ VS Check

Provide complete background check of local and national records.

Police Information/ VS Check— Volunteers for Non-profit Organizations

Provide complete background check of local and national records for volunteers for bona fide registered non-profit organizations where no remuneration is received. Letter on organization's letterhead and registration number must validate the application.

Chauffeur's Permit

Provide a driver record check and Police Information/ VS check.

Mechanical Inspection

RCMP requires a mechanical inspection in serious motor vehicle accidents. A certified mechanical engineer's report is required to ascertain whether an accident was caused by human source and/or mechanical problems.

Measurements

Accident scene measurements required in serious motor vehicle accidents

Plan Drawing

Traffic analysts provide an overview of an accident via field drawings, sketches, etc.

Photographs

Photographs of accident scenes, break and enters, willful damage, property damage, etc. 6 photographs laser printed per page; printed on regular paper
