SUBJECT: PRINCE RUPERT BVLD. LAND SALE INFORMATION REQUEST

RECOMMENDATION:

THAT Council receives and files this Report as requested.

REASON FOR REPORT:

The Digby Towers is preparing for occupancy and the building requires appropriate parking. The Council has requested this short explanation Report on the proposed Bylaw and Disposition.

ANALYSIS:

The Digby Tower property owner has requested to purchase a linear parcel across from their building and the Council has agreed to sell it at market value. In order to protect access to the neighbouring property (Motel), a Road Dedication Bylaw is required and contemplated in Bylaw #3512. Please note that clearing, grubbing, and tree removal of the area will be required in order to facilitate the creation of parking.

Additionally, the City owns a parcel that bisects the Digby Tower's current parking lot and the Digby Tower owns the property that terminates an opportunity for the current lane to provide connected access for fire protection and the public. Therefore, to correct this and allow for a uniform parking lot the Council has Resolved to complete a property exchange as the properties are very similar in size.







SUBJECT: APPLICATION TO UBCM POVERTY REDUCTION FUND PLANNING

STREAM

RECOMMENDATION:

THAT Council support a City application to the UBCM Poverty Reduction Planning Grant for \$25,000.

REASON FOR REPORT:

The City has identified available funding through the UBCM for Poverty Reduction Planning stream, which would support Council's identification of Social Development Planning as a priority both in the recent Strategic Plan, as well as the Official Community Plan.

BACKGROUND:

In March 2019, the Province of BC released their poverty reduction strategy: TogetherBC: British Columbia's Poverty Reduction Strategy. Mandated through the Poverty Reduction Strategy Act, the strategy is based on four principles: affordability, opportunity, reconciliation, and social inclusion. As a component of the implementation of their strategy, the Province is offering funding to municipalities to support poverty reduction efforts in both planning and programming streams. City Council has identified a number of concerns with respect to conditions surrounding poverty, affordability, and mental health and addictions supports, in the community, and while outside the traditional realm of municipal responsibility, this funding opportunity presents an opportunity for the City to play a supporting role in addressing these issues. A Poverty Reduction/Social Development Assessment and Plan will support local social development and poverty reduction by focusing on opportunities for the municipality to integrate proposed considerations, and by providing local data that supports funding requests of our external partners for programming supports.

ANALYSIS:

In consideration of funds available through this program, the objectives of the Social Development + Poverty Reduction Plan and associated workplan are listed below.

March 6th, 2023

- To provide a review and assessment of the demand and supply of social services in Prince Rupert – specifically relating to housing, mental health and addictions supports, and income supports, with information regarding programming use from underserved populations being a key component of data collection – including and especially Indigenous residents and residents with disabilities.
- To obtain policy recommendations with respect to gaps identified within the assessment that fall within the tools and services available to the municipality;
- Once completed, this plan will enable local organizational eligibility for funding under the Poverty Reduction Action stream of the Provincial TogetherBC Poverty Reduction program, as well as support other local initiatives seeking funding;

Overall, this funding will support the City in identifying first steps that the municipality can take to support poverty reduction in Prince Rupert. This will be in complement to existing policy changes that occurred as a result of the Child Care Assessment and Action Plan, as well as the City's collaboration with different local providers to provide land for affordable and supportive housing developments. Data and information collected can also support complementary activities and policy recommendations from the City's Accessibility and Reconciliation Committees.

LINK TO STRATEGIC PLAN:

The development of a "Social Development Plan" was identified by Council as a main priority in the 2023-2024 in Council's Strategic Plan. This funding stream presents a unique opportunity to achieve Council's objective with no impact to proposed budget for 2023-2024.

COST:

Funding from UBCM covers 100% of costs up to \$25,000, and the City will apply for the maximum available amount. Additional costs will be staff time for overseeing the project and supporting engagement efforts. Potential future costs, should they arise, may arise for implementation of proposed plan objectives; however, completion of this plan also opens Prince Rupert up to additional eligibility for the Poverty Reduction Program funding stream, which could then be applied to by the City and/or our partner organizations to implement recommendations.

Dear Mayor Pond:

I am writing in response to your letter of November 22, 2022, addressed to the Honourable Omar Alghabra, Minister of Transport, and subsequently forwarded to my office, regarding the City of Prince Rupert's water infrastructure challenges. As outlined in my January 31, 2023 response on this matter to Member of Parliament Taylor Bachrach to which you were copied, I am aware of the issue, and I sympathize with the City's residents.

The Government of Canada is making unprecedented investments in areas such as public transit, resilient and low-carbon infrastructure, water and wastewater, and green and inclusive community buildings, all of which contribute to economic growth, social inclusion, and a healthy environment.

Depending on the emergency level, there are programs in place under the purview of my colleague the Minister of Emergency Preparedness that could assist the City of Prince Rupert. Public Safety Canada coordinates emergency management requests that are beyond the capabilities of the province through a formal request for federal assistance process. Their Government Operations Centre is available to assist with questions about that well-established process.

The Government of Canada works closely with provincial, territorial, municipal and Indigenous partners to fund infrastructure projects, but it is these orders of government that are responsible for the planning, prioritization, design, financing and operation of their infrastructure assets. Once projects are submitted to Infrastructure Canada, they are reviewed against the terms and conditions of our funding program before coming to me, as Minister of Intergovernmental Affairs, Infrastructure and Communities, for decision.

As you know, the City of Prince Rupert's water infrastructure challenges were discussed on several occasions in the last months between my officials, Transport Canada officials, provincial officials from Municipal Affairs and Prince Rupert officials. However, as of late last year, British Columbia identified planned investments that would allocate the majority of the remaining funding under the Investing in Canada Infrastructure Program (ICIP).

Although it might not be possible for British Columbia to prioritize the water distribution replacement project for ICIP funding, I nevertheless encourage the City of Prince Rupert to continue exploring alternative solutions with the province. I was pleased to see Minister Kang launching the Growing Communities Fund, which could be an option for your municipality.

Once again, thank you for taking the time to write on this important matter. Together, we will work to ensure that infrastructure plays a vital role in promoting economic growth, job creation and improving our quality of life in the coming months and years.



Government of Canada and FCM support **Innovative Wastewater Projects in the City of Prince Rupert**

March 2, 2023

Across the country, Canadians are feeling the impacts of climate change. By investing in community initiatives that cut pollution and support efficient local infrastructure, we can build strong and healthy communities for everyone to call home. This is why the Government of Canada and the Federation of Canadian Municipalities (FCM) are investing in smart, sustainable solutions from coast to coast to coast.

The Honourable Jonathan Wilkinson, Minister of Natural Resources, and FCM President Taneen Rudyk today announced an investment of \$487,000 to the City of Prince Rupert for an innovative wastewater management system.

The funding (\$400,000) will support a pilot project to install a new wastewater treatment technology and explore how it can be integrated with local soils, plants and other features of the natural landscape. If successful, the new system could be replicated across the city, creating significant cost savings while improving water quality in the port of Prince Rupert, allowing for a healthier marine environment and greater recreational opportunities.

This pilot project builds on the results of a feasibility study completed by the City of Prince Rupert in 2020. That study, also funded by the Green Municipal Fund (GMF) (\$87,000), outlined the benefits of using this type of wastewater treatment technology and identified an optimal site for pilot testing.

The funding announced today comes from the Green Municipal Fund (GMF), administered by the Federation of Canadian Municipalities and funded through an endowment by the Government of Canada. GMF helps local governments switch to sustainable practices faster by giving municipalities the tools they need to reduce greenhouse gas emissions and build climate change. By taking action to adapt to climate change we can build communities and economies that are able to thrive for generations to come.

If you are continuing in your elected position, thank you for your service to British Columbians. And if you are newly elected, welcome to your very important role.

My office takes complaints from the public about all of the local governments in BC. We are an oversight body, one of the independent offices of the Legislature, and our mandate is to be BC's independent voice for fairness and accountability of the public sector. When we receive people's concerns about public services, we conduct impartial investigations and address the fairness problems that we find. For local governments, that means you may hear from us when we have received a complaint about your municipality and are investigating to determine whether the standard of fair and reasonable service set out in the *Ombudsperson Act* has been met. Where fairness issues are identified, we can consult with you to find a way to address the issues in order to ensure fairness moving forward.

We are also available to help. Our <u>Public Authority Consultation and Training team</u> can assist you with any questions about fairness you may have. A number of <u>useful resources</u> are also available on our website, including:

RECOMMENDATION:

THAT Council give First, Second and Third Reading to the City of Prince Rupert Adjudication Bylaw No. 3497, 2023.

REASON FOR REPORT:

The City of Prince Rupert was accepted into an adjudication for municipal tickets that will help to streamline the process. In order to qualify for adjudication a bylaw must be passed identifying which bylaws may be considered for adjudication.

Initiating formal court proceedings can be costly and can discourage enforcement if voluntary compliance is not forthcoming. Bylaw adjudication also permits the delivery of bylaw infraction notices by mail, regular mail. In addition, through adjudication, disputes will be resolved locally with a minimum of processing, those challenging tickets do not have to wait to go to court and there will be no requirement to leave work to attend a hearing.

COST:

There is no financial cost to the City for the implementation of this bylaw.

CITY OF PRINCE RUPERT

ADJUDICATION BYLAW NO. 3497, 2023

A BYLAW TO PROVIDE FOR ENFORCEMENT BY BYLAW NOTICES

WHEREAS the Local Government Bylaw Notice Enforcement Act, S.B.C, 2003, c. 60 empowers the Council of the City of Prince Rupert, by Bylaw, to designate those bylaws for which bylaw notice enforcement may be used;

NOW THEREFORE the Council of City of Prince Rupert in open meeting assembled, enacts as follows:

PART 1 – INTRODUCTION

Title

1. This Bylaw may be cited as "City of Prince Bylaw Notice Enforcement Bylaw No. 3497, 2022".

PART 2 – DEFINITIONS

2. In this Bylaw:

"Act' means Local Government Bylaw Notice Enforcement Act,

"Bylaw Enforcement Officer" means a person or person appointed by Council, or their designate, from time to time to enforce the regulatory bylaws of the municipality;

"City" means the City of Prince Rupert;

"Designated Bylaw" means a bylaw listed in Column 1 of Schedule "A" to this bylaw;

"Designated Schedule" means the schedule specified in Columba 3 of Schedule "A" to this bylaw that corresponds with and is attached to the Designated Bylaw being enforced; and,

"Registry" means the Bylaw Notice Adjudication Registry established pursuant to this bylaw.

PART 3 – STATUTORY TERMS

3. Subject to subsection 2, the terms of this bylaw have the same meaning as the terms defined in the Act.

PART 4 – BYLAW CONTRAVENTIONS

4. The bylaws listed in Column 1 of Schedule "A" to this Bylaw may be dealt with by bylaw notice.

PART 5 – PENALTY OR DISPUTE

- 5.1 A person who receives a bylaw notice must, within 14 days of the date on which the person received or is presumed to have received the bylaw notice:
 - Pay to the City the penalty in the amount specified in Column A5 (Early Payment) of the Designated Schedule for the contravention; or,
 - b. Request dispute adjudication by filling in the appropriate portion of the bylaw notice indicating either an intention to dispute and delivering it, either in person during regular office hours, or by mail, to the City.

PAYING FOR A DISPUTE NOTICE

- 5.2 If a person receives a bylaw notice but falls to pay the penalty or dispute the bylaw notice in the time required under section 5.1 of this bylaw, that person must:
 - a. Pay to the City the penalty in the amount specified in Column A4 of the Designated Schedule for the contravention if the payment is received by the City within 30 days of the date on which the person received the bylaw notice or is presumed to have received the bylaw notice; or
 - b. Pay to the City the penalty in the amount specified in Column A6 of the Designated Schedule for the contravention.
- 5.3 Where a person was not personally served with a bylaw notice and advises the City, in accordance with the requirements of Section 25 of the Act, that they did not receive a copy of the original notice, the time limits for responding to a bylaw notice under subsection 5.1 and making a payment under subsection 5.2 of this bylaw do not begin to run until a copy of the bylaw notice is redelivered to them in accordance with the Act.

PART 6 – BYLAW NOTICE DISPUTE ADJUDICATION REGISTRY

6.1 The Registry is established to provide a bylaw notice dispute adjudication system for the purpose of hearing disputes in accordance with the Act.

- 6.2 The civic address of the Registry is the City of Prince Rupert, 424 Third Avenue West, Prince Rupert, BC, V8J 1L7
- 6.3 Every person who is unsuccessful in a dispute adjudication hearing in relation to a bylaw notice or a compliance agreement under the dispute adjudication system established under this section must pay the City an additional fee of \$25.00 for the purpose of the City recovering the costs of the adjudication system

PART 7 – SCREENING OFFICERS

- 7.1 The following may be appointed as screening officers:
 - a. Corporate Administrator,
 - b. City Manager;
 - c. Bylaw Officer; or,
 - d. Any other officer, employee or contractor of the City upon the recommendation of the Corporate Administrator or City Manager.

PART 8 – POWERS, DUTIES AND FUNCTIONS OF SCREENING OFFICERS

- 8.1 The powers, duties, and functions of screening officers are as set out in the Act, and include the following powers:
 - a. where requested by the person against whom a contravention is alleged, to communicate information respecting the nature of the contravention, the provision of the bylaw contravened, the facts on which the contravention allegation is based, the penalty for a contravention, the opportunity to enter into a compliance agreement, the opportunity to proceed to the bylaw notice dispute adjudication system and the fee or fees payable in relation to the bylaw notice enforcement process;
 - b. to communicate with any or all of the following for the purposes of performing their functions under this bylaw or the Act:
 - (i) the person against whom a contravention is alleged or their representative;
 - (ii) the officer issuing the notice:
 - (iii) the complainant or their representative; and
 - (iv) the City's staff and records regarding the disputant's history of bylaw compliance;
 - c. To prepare and enter into compliance agreements under the Act with persons who dispute bylaw notices, including to establish terms and conditions for compliance that the Screening Officer considers necessary or

- advisable, including time periods for payment of penalties and compliance with the bylaw;
- d. To enable the payment of a reduced penalty if a compliance agreement is entered into, as provided in each bylaw; and
- e. To cancel bylaw notices in accordance with the Act and City policies and guidelines.
- 8.2 Screening Officer may only enter into a compliance agreement for a contravention that is indicated as being available for a compliance agreement under Column A7 of the Designated Schedule.
- 8.3 The maximum duration of a compliance agreement is one year.

PART 9 – ADMINISTRATIVE

- 9.1 Schedule "A" is attached to this bylaw and forms a part of this bylaw.
- 9.2 If any provision of this bylaw is declared or held to be illegal, invalid, or ultra vires, in whole or in part, then the provision shall not apply and the remainder of this bylaw shall be in full force and effect and be construed as if it had been enacted without the illegal, invalid or ultra vires provision.

CITY OF PRINCE RUPERT

FIRE CONTROL AND PROTECTION AMENDMENT BYLAW NO. 3515, 2022

A BYLAW TO AMEND THE CITY OF PRINCE RUPERT FIRE CONTROL AND PROTECTION BYLAW NO. 2944, 1995, AS AMENDED

WHEREAS Council of City of Prince Rupert has enacted a Fire Control and Protection Bylaw;

NOW THEREFORE the Council of City of Prince Rupert in open meeting assembled, enacts as follows:

- 1. The "City of Prince Rupert Fire Control and Protection Bylaw No. 2944, 1995 as amended" be further amended by:
 - a. Add to section 2.0 Definitions:

"Container" means a large, strong container, usually of metal used to store goods, usually for shipment. May also be described as a "Sea-Can", "Storage Container", "Shipping Container" or "Cargo Container".

- b. Add section for "Containers":
 - i. Code Compliance:

The Container must meet, or exceed as indicated, all relevant requirements of BC Safety Codes such as, but not limited to:

- Division B Part 3 & Division B Part 4 of the BC Fire Code will apply in all cases
- There will be no electrical to the container unless it meets or exceeds all requirements of the BC Building, Fire and Electrical Codes for explosive/moist/wet environments. It must by fully explosion proof and tested regularly to ensure compliance.
- Dangerous Goods storage shall be restricted to materials that are declared at the permit stage. Any changes to the type of dangerous goods must be approved by the City of Prince Rupert.
- No smoke shall be allowed in Containers.
- Where flammable liquids and combustible liquids are stored in the Container, combustible construction shall be removed, provisions for spill containment installed and the container shall be grounded. The dispensing of flammable liquids and the storage of open containers shall be prohibited in the Container.

Compressed gases shall not be stored in the Containers.
 Limited amounts of aerosols shall be stored in the Containers only when stored in metal cabinets.

ii. Location:

The Container must be positioned such that:

- There is a minimum separation of 1.5m between any noncombustible structure and the Container to allow for fire fighting access to the exposed structures.
- The Container must be located at least 6m from exits, windows or unprotected openings of an exposed building.
- Greater separation distances will be required based upon exposure to any combustible materials or structure.
- The Container doors are positioned such that they face away from any other structure.
- The Container doors must be positioned such that they face away from any means of road access to the Container for fire personnel.
- No combustible materials may be stored near the Container.
- Containers shall not be installed under power lines.

iii. Identification:

The Container must be identified such that:

- UN Placards for all stored Dangerous Goods must be visible on the two Container sides visible to emergency responders.
- The name of the company/person responsible for the Container and an emergency telephone contact number must be marked on the Container in lettering visible from 10m.
- The Container and contents must be identified in the Fire Safety Plan.

iv. Safety Features to be added:

The Container must have the following safety features in place prior to any use:

- One ventilation opening must be added within 150mm of the floor in the container door primarily used for opening.
- One ventilation opening must be added within 150mm from the top of the container on the opposite end from the doors from cross ventilation.
- The high ventilation opening cannot be directly venting toward a structure
- Neither ventilation opening can be obstructed by stored materials at any time and must be kept clean of internal and external debris.
- The additional ventilation openings must be constructed based upon the following minimums:
 - Two 0.3m x 0.3m openings for a Container 6m or less.
 - Two 0.5m x 0.5m openings for a Container over 6m.

- Both openings will be covered by open grate wire mesh with greater than 50% free area.
- Higher opening will also have a wind vent device, designated to generate a venturi effect during low wind speeds.
- Where heavier than air flammable and combustible liquids are stored in the Container a ventilation opening a low level should also be installed at the opposite end from the doors.
- Where 1A flammable liquids in quantities greater than 4 litres are stored in the Container then provisions shall be made to comply with the requirements for withstanding an internal explosion as per the BC Fire Code, BC Building Code and NFPA 68.
- Alternate engineering solutions for ventilation and explosion protection will be considered

NOTE: Standard existing environmental vents normally built into Containers **are not acceptable** as ventilation openings for land-based storage applications. These vents were designed for air movement based upon atmospheric weather changes only and do not provide for adequate air flow.

3. This Bylaw may be cited as "City of Prince Rupert Fire Control and Protection Amendment Bylaw No. 3515, 2023".

BEING A BYLAW TO OPEN A PORTION OF HIGHWAY ROAD ALLOWANCE

Pursuant to Section 40 of the *Community Charter*, Prince Rupert City Council may, by bylaw, open a portion of a highway to traffic through the dedication of the highway.

The Council of the City of Prince Rupert deems that it is in the public interest to open to traffic a dedication of highway comprising of approximately 203.7 square meters dedicated on Plan EPP120581, which is shown outlined in bold black on the reference plan prepared by McElhanney, on the 14 day of December, 2022, a reduced copy of which is attached hereto (the "Road Dedication Plan");

The City intends to open that portion of highway to allow through traffic in front of 200 Prince Rupert Boulevard.

The Council of the City of Prince Rupert, in an open meeting assembled, enacts as follows:

- 1. Attached to this Bylaw as Schedule "A" and forming part of this Bylaw is a reduced copy of the explanatory plan of highway dedication (the "Road Dedication Plan").
- 2. The City hereby authorizes the dedication to traffic and highway of the 203.7 square meters portion of highway which will be dedicated as highway at the New Westminster Land Title Office by Plan EPP120581, outlined in Bold on the Road Dedication Plan (the "Dedicated as Road").
- 3. On deposit of the Road Dedication Plan and all other documentation for the dedication of the road allowance in the New Westminster Land Title Office.



HIGHWAY ROAD CLOSURE BYLAW NO. 3513, 2023

BEING A BYLAW TO CLOSE A PORTION OF HIGHWAY ALLOWANCE

Pursuant to Section 40 of the *Community Charter*, Prince Rupert City Council may, by bylaw, close a portion of a highway to traffic and remove the dedication of the highway, if prior to adopting the bylaw, Council publishes notices of its intention in a newspaper and provides an opportunity for persons who consider they are affected by the bylaw to make representations to Council;

The Council of the City of Prince Rupert deems that it is in the public interest to close to traffic, remove the dedication of highway comprising of approximately 252.4 sqm of dedicated Highway on Plan 923, which is shown outlined in bold black on the reference plan EPP124015 prepared by McElhanney, a reduced copy of which is attached hereto (the "Road Closure Plan");

The City intends to close that portion of highway to sell and consolidate it to a neighbouring lot.

Notices of Council's intention to close that portion of highway to traffic, to remove its dedication as highway, and published in a newspaper and posted in the public notice posting place, and the Council has provided an opportunity for persons who consider they are affected by the closure and disposition to make representations to Council; and

The Council of the City of Prince Rupert does not consider that the closure of the Closed Road will affect the transmission or distribution facilities or works of utility operators;

The Council of the City of Prince Rupert, in an Open meeting assembled, enacts as follows:

- 1. Attached to this Bylaw as Schedule "A" and forming part of this Bylaw is a reduced copy of the explanatory plan of highway closure (the "Road Closure Plan").
- The City hereby authorizes the closure to traffic and removal of highway dedication of the 252.4 sqm portion of highway which was dedicated as

- highway at the New Westminster Land Title Office by Plan 923, outlined in Bold on the Road Closure Plan (the "Closed Road").
- On deposit of the Road Closure Plan and all other documentation for the closure of the road allowance in the New Westminster Land Title Office, the Closed Road is closed to public traffic, it shall cease to be public highway, and its dedication as a highway is cancelled.
- 4. The Mayor and Corporate Administrator are authorized to execute all deeds of land, plans and other documentation necessary to effect this road closure and disposition.
- 5. This Bylaw may be cited as <u>"HIGHWAY CLOSURE BYLAW NO. 3513, 2023"</u>
