CITY OF PRINCE RUPERT

REVISION BYLAW NO. 3444, 2019

BEING A BYLAW TO AUTHORIZE THE REVISION OF A BYLAW

WHEREAS section 140 of the *Community Charter* permits a Council, by bylaw, to authorize the revision of all or any of the bylaws of the municipality in accordance with the *Bylaw Revision Regulation* (B.C. Reg. 367/2003);

AND WHEREAS the City has identified a clerical error in City of Prince Rupert Bylaw No. 3438, 2019 and Prince Rupert Bylaw No. 3439, 2019 that requires a revision to improve the expression of the law without changing its substance.

NOW THEREFORE the Council of the City of Prince Rupert, in open meeting assembled enacts as follows:

TITLE

1. This bylaw may be cited for all purposes as "City of Prince Rupert Revision Bylaw No. 3444, 2019".

BYLAW REVISION

- 2. The City of Prince Rupert Bylaw No. 3438, 2019 is hereby revised by attaching the Schedule "A" attached hereto.
- 3. The City of Prince Rupert Bylaw No. 3439, 2019 is hereby revised by attaching the Schedule "A" attached hereto.

ADOPTION OF THE REVISED BYLAW

- 4. The revised City of Prince Rupert Bylaw No. 3438, 2019 shall take effect:
 - a) following the certification of the Corporate Administrator prior to the third reading that it has been revised in accordance with this bylaw, and
 - b) upon its subsequent adoption by the Council




- 5. The revised City of Prince Rupert Bylaw No. 3439, 2019 shall take effect:
